NO SOLICITORS

EUCLID ORDINANCE 757.13
PEDDLING FORBIDDEN WHERE SIGN PROHIBITS.

No peddler or solicitor or any person pretending to be a peddler or solicitor, for the purpose of peddling or pretending to peddle or solicit, shall ring the bell or knock at any building whereon there is painted, affixed or otherwise displayed to public view any sign containing any or all of the following words: "No Peddlers," "No Solicitors" or "No Agents," or which otherwise purports to prohibit peddling or soliciting on the premises.



Crime Prevention

Encourage your neighbors to post a no solicitors sign if they do not want door to door solicitors to knock or ring the doorbell.

Neighbors should be in agreement that any suspicious door to door activity should be reported to the Euclid Police Department immediately so that an officer can investigate.

Crime Prevention

Crime prevention is everyone's business. In order to keep our neighborhoods safe we must all take an active role to observe and report suspicious activities. Door to door soliciting should always be considered a suspicious activity if the solicitor is not following Euclid's ordinances, or you feel the person is not legitimate.

Criminals like to imitate door to door soliciting to blend into a neighborhood. This gives them time to check out unoccupied houses and find entry points. Be alert to such activities as adults and children who are looking for yard work, selling from plastic tubs, or asking for donations. Although many non-profit and religious solicitors are from valid organizations, the criminals are blending in and using this as a tool to steal from you!

Euclid Ordinances

Solicitors and peddlers within the City of Euclid must follow all of Euclid's ordinances.

757.02 PEDDLING AT PRIVATE RESIDENCES. No person who has not obtained a permit or license, or both, as required by this chapter, shall go in or upon residential property, or ring a doorbell, or knock on a door of a private residence, including an apartment, not having been requested or invited to do so by the owner, occupant or lessee of such private residence or apartment, for the purpose of soliciting orders for the sale of goods, wares or merchandise, or peddling or hawking goods, wares or merchandise.

If you do not want door to door solicitors to knock or ring your doorbell, you must post a sign stating "No Solicitors".

EUCLID ORDINANCE 757.13 PEDDLING FORBIDDEN WHERE SIGN PROHIBITS.

No peddler or solicitor or any person pretending to be a peddler or solicitor, for the purpose of peddling or pretending to peddle or solicit, shall ring the bell or knock at any building whereon there is painted, affixed or otherwise displayed to public view any sign containing any or all of the following words: "No Peddlers," "No Solicitors" or "No Agents," or which otherwise purports to prohibit peddling or soliciting on the premises.

Solicitors need a permit issued from the police department.

757.04 POLICE DEPARTMENT PERMIT REQUIRED. No person shall be issued a license by the Chief of Police unless such person first has been issued a permit for peddling or soliciting by the Police Department, or has obtained a clearance from the Law Department stating that no license is required.

Use the back of this flap as a sign to post in a visible place near or on your door to prohibit solicitors from knocking or ringing your doorbell.
